Your business idea or invention may be novel enough to qualify for patenting, design registration or similar protection. Software is generally not patentable, but there are exceptions. You may also have a special name or logo that can be trademarked. All these intellectual property aspects can be very valuable, if registered properly in all the markets/ countries where you think you will trade. This requires the services and advice of an IP law firm, and the best way is to contact them and ask for a consultation.
